

**BURSARY APPLICATIONS PROCEDURE & REGULATIONS**  
**For Guildhall Young Artists Taunton (GYAT)**  
**Academic Year 2023-24**

1. Applications should be submitted via the online form no later than 5pm on Tuesday 27 June 2023 which deadline will not be extended.
2. Documentary evidence should be provided for ALL income listed on the form.
3. Applicants must show evidence of trying to find funding from other appropriate sources. At least 2 other applications should be made; copies of correspondence sent to the organisations must be provided to GYAT to support the bursary application.
4. Further documentary evidence might be requested to substantiate information supplied on the application form.  
*Failure to produce documentary evidence outlined above may mean that the application will not be considered by the bursary assessment panel.*
5. A few days after the deadline of 27/06/23, the bursary assessment panel, of GYAT and Guildhall School senior management and the head of Somerset's Music Education Hub, will assess a priority order in all the valid applications that are made, using financial need, student potential & student commitment (existing students) as the principal criteria. Approaches will then be made to Charitable Trusts and organisations on the applicant's behalf. Applicants will be informed of the result during late July 2023. Awards are made for a whole academic year.
6. Should an application be unsuccessful, applicants will remain at liberty to make a successive application for the following academic year. In cases of emergency or changes in an applicant's financial situation, further applications during the academic year may be made.
7. There will usually be one emergency bursary meeting held midway through each term.
8. Should an application be successful, the applicant will be bound to inform the Head of GYAT:
  - of any significant change in financial circumstances;
  - of any funding found from other trust funds or charitable organisations.
9. Awards are dependent on the recipient upholding GYAT's Student Code of Conduct and regulations and in particular the following:
  - completion of the academic year 2023-24;
  - satisfactory progress made throughout the year;
  - regular attendance during term time;
  - attendance at all relevant concerts and important rehearsals.*The bursary assessment panel reserves the right to withdraw part or all of an award if the applicant defaults in No.8 above or if the recipient defaults in one or more points in No.9 above.*
10. Awards are tenable for the academic year 2023-24 only. A further application will need to be made in the summer term 2024 (date to be confirmed) if funding is required from September 2024.

*Please note that information you provide through the Bursary Application Form will be used for the purpose of deciding whether Guildhall School is able to provide financial assistance and for aiding the Head of GYAT in applying to granting bodies or charitable trusts for funding. Members of the bursary assessment panel will have access to this information when meeting to decide on bursary allocations.
