

2025 ENTRY SUPPORTED APPLICATION SCHEME

INSTRUCTIONS FOR APPLICANTS

Eligibility

To be eligible for the 2025 Supported Application Scheme, you **must**:

- Have **no** previous experience of university.
- Be applying for an eligible undergraduate programme.
- Be UK-Domiciled.
- Be living in a household with a gross annual income of below £35,000 OR in a household that
 receives means tested state benefits OR in receipt of Free School Meals or a 16-19 bursary
 OR in receipt of a means tested bursary in a Guildhall Young Artists' Centre.

You must also meet at least one of the below criteria:

- Have a home postcode which is classified as Quintile 1 or Quintile 2 in the POLAR4 dataset.
 - POLAR4 is a dataset which groups areas of the UK based on the proportion of young people progressing to higher education (<u>Visit the Office for Students website</u> to use the postcode checker. Alternatively email <u>wp@gsmd.ac.uk</u> with your home postcode to check).
- Have a home postcode which is classified as Decile 1-4 in the Index of Multiple Deprivation (IMD) Government dataset.
 - o IMD is the official measure of relative deprivation areas of England (<u>visit the IMD</u> <u>website to check</u>, the result is in a downloadable spreadsheet, found in column F alternatively email <u>wp@gsmd.ac.uk</u> with your home postcode to check).
- Be Black, Asian or ethnically diverse.
- Be in care, a recent care leaver, or estranged from your family.
 - Recent Care Leaver is defined as someone who has been in local authority care for at least 13 weeks in the last 5 years.
 - Estrangement is defined as having no contact with parents in the last 12 months, and being unlikely to have a relationship with them again
- Have a declared disability.
- Have attended a state school or college for the entirety of your education.
 - o This means that you attended a school or college that did not charge any fees to any pupils, and was instead funded by the local authority.
- Have a full bursary to attend a fee-paying school or are home schooled.

Step One - Application and Referral

There are two ways to apply for the Supported Application Scheme:

- Apply directly.
 - o If you choose this option, you will be required to provide evidence for some criteria.
- Referral from a school, college, theatre group or youth organisation.
 - Please speak with your teacher or youth worker about the possibility of referring you to the scheme. If they are not aware of the scheme and have any questions, ask them to get in contact directly with our Access and Participation team (<u>access@gsmd.ac.uk</u>).

Applications and referrals should be submitted via the application form found on the webpages, or HERE.

The deadline for applying to the Supported Application Scheme is dependent on the undergraduate course you are applying to:

Evidence of Eligibility

If you apply directly to the Scheme, further evidence will be requested to confirm your eligibility. The following outlines evidence that may be required:

A copy of a recent letter that outlines entitlement to an income-assessed benefit. Please ensure that this letter also contains your home address. An official letter from your school, college or GYA Centre that outlines entitlement to Free School Meals or a bursary. A copy of a P60(s) that demonstrates that household income is below £35k per year.
Eligible POLAR4 postcode	Proof of address is required for the programme – postcode will be checked.
Eligible IMD postcode	Proof of address is required for the programme – postcode will be checked.
Black, Asian or ethnically diverse	No evidence required.
In care, recent care leaver or	Proof of your time in care or estrangement, such as a letter
estranged from family	from a social worker, teacher or doctor.
Have a disability	A letter or document from a medical professional.
Attended a state school or	Proof that you attended a state school from years 7-13 (or 7-11,
college	and two years of sixth form/college). You may like to contact
	your school to provide a letter stating this, or you can upload
	exam certificates if they outline your place of study.
Have a full bursary to attend a	Proof that you receive a full bursary/ scholarship to attend a
fee-paying school	fee-paying. This should be a letter from your school.

Evidence must be uploaded at the point of application, or you can email this directly to access@gsmd.ac.uk. Your application cannot be processed until evidence is provided.

- Once your application for the Supported Application Scheme has been received and
 processed, you will receive an email from the Access and Participation Team to let you
 know if you have been offered a place, and your free application link. Please add
 <u>access@gsmd.ac.uk</u> to your email contact list, to prevent this email going into any junk
 folders.
- If you are being referred to the Scheme, your referee will require your full name, date of birth, email address, home address, course you are applying to and knowledge of which criteria you meet. If you have previously submitted an application to Guildhall School please also give them your applicant number. Please note that you must provide the name and email address which you intend to use on your course application.

Step Two – Unique link to the online application

- If you are accepted on the Supported Application Scheme, you will be sent a **unique login link** to the online application form for the undergraduate programme.
- Please do not share this link with anyone else as it may make your application invalid.
 Additionally, anyone who uses a free application link who has not been accepted onto the Supported Application Scheme will have their application cancelled.
- Do not use any link to the online course application other than the unique link you have been sent. If you use the link on the 'How to Apply' page on the website, you will be creating a new application that requires payment in order to be submitted.
- Please do not submit an application to an undergraduate programme until you have received
 your unique login link we cannot reimburse application fees once they have been paid. If
 you do pay for your application, you can still be part of the Supported Application Scheme if
 eligible, you will just miss out on the free application.

Step Three – Your Undergraduate application

- Click on the link you have been sent to start your application. You should save this email as
 you will need to always use this unique link to access your application again.
- In order to assist you with the completion of your application form, we will send Scheme
 participants a detailed application guide, which will be attached to the confirmation email. If you
 do not have easy access to a computer or the internet, or if you would like more advice on
 completing the form, please get in touch with the Access and Participation team.
- Please remember that acceptance onto the Supported Application Scheme is not an
 application to the undergraduate programme you must complete your application by the
 published deadlines. Any Supported Application Scheme participant who has not completed
 their application by the relevant deadline will be removed from the Scheme, and the free
 application will no longer be valid.
